## 2014 Annual Meeting Reconvened

The 2014 Annual Meeting was reconvened on February 19, 2014, at 6:30 PM. The proxies from the January 15 meeting were still valid and helped constitute a quorum.

Votes from members who had not received their original packets for one reason or another were added to the original count on the two issues of adding sliding doors to the clubhouse (to replace the three windows on the wall adjacent to the pool) and extending the pool deck an additional 10 feet.

The results were:

Issues	Yes	No
Sliding Doors	60	10
Pool Deck Expansion	58	12

Both issues passed. The regular monthly BOD meeting was held immediately following the adjournment of the Annual Meeting. Both projects were approved by the BOD. It was decided the sliding doors should be done first. The vendor was chosen, and the project will be started as soon as the vendor, *Sundance Construction*, can get permits and get us on the schedule.

A vendor has been approved by the BOD for the pool expansion project and we are awaiting permits to begin.
